

that the report of the Local Inquiry Committee for First Time Recognition for the Ph.D.(Commerce) degree course in the subject of Accountancy was placed before the Board of Deans at its meeting held on 17th April, 2018, vide item No.47, when it was resolved as under :-

You are therefore, requested to pay the remaining fees of Rs.40,000/- (Rupees Forty Thousand Only). towards the Continuation of Recognition from the academic year 2019-20 to 2022-23, within 15 days, as a precondition for approval of first time recognition.

Further, you are also requested to submit the proposal for continuation of recognition for the academic year 2023-24 onwards, on or before 30th September, 2022.
