Madam / Sir,

With reference to the subject above, I am directed by the Hon'ble Pro-Vice-Chancellor to inform you that the report of the Local Inquiry Committee for **First Time Recognition** for the **Ph.D.(Commerce)** degree course in the subject of **Accountancy** was placed before the Board of Deans at its meeting held on **17<sup>th</sup> April, 2018**, vide item No.47, when it was resolved as under :-

"be granted **First Time Recognition** to enroll 10 students for the **Ph.D.(Commerce)** degree in the subject of **Accountancy** for the Academic Year 2018-19 (instead of 2017-18) subject to yearly review of compliance of conditions stipulated by the LIC Committee & recovery of dues towards recognition fees, if any & the same be recommended to Vice-Chancellor for his consideration & approval."

Pursuant to the above resolution of the Board of Deans, I am to inform you that the College/Institute has been granted permission for **First Time Recognition** to enroll (10) ten students for the **Ph.D.(Commerce)** degree course in the subject of **Accountancy** for a period of five years from the **Academic Year 2018-19 to 2022-23**.

The Local Inquiry Committee in its report recommended the following conditions:-

- 1) That the college shall follow the Ordinances, Rules and Regulation related to the admission and maintenance of standard of Ph.D. program issued University and UGC.
- 2) That the College shall participate in the conduct of PET examination and evaluation of answer books of PET examination as and when the University needs its help.
- 3) The college shall charge the fees as per University norms.
- 4) The College should procure sufficient reference books and journals overseas.

You are therefore requested to comply with the aforesaid conditions recommended by the Local Inquiry Committee and submit your report in the matter, at the earliest, failing which the matter will be reported to University Authorities.

You are therefore, requested to pay the remaining fees of Rs.40,000/- (Rupees Forty Thousand Only) towards the Continuation of Recognition from the academic year 2019-20 to 2022-23, within 15 days, as a precondition for approval of first time recognition.

Further, you are also requested to submit the proposal for continuation of recognition for the academic year 2023-24 onwards, on or before 30<sup>th</sup> September, 2022.
